When is ethnic mobilization most likely:

- -structure of political access and participation is organized along ethic lines (regional/administrative boundaries)
- -official castes/quotas/reserved seats
- -policies recognize/institutionalize ethnic differences (official languages, designated lands)
- -ethnic boundaries that offer official access to special treatment

- -chewas and tumbukas are big enough groups to base political coalitions in malawi.
- -too small for political competition in zambia so they end up just being "northerners"
- -leader driven approach

VIOLENCE

Wilkison - key independent variable: electoral incentives - related to posner -politicians want to mobilize ethnic base. If they are an elite dominated party, they can't promise patronage. So they make ethnicity salient by engineering riots

-if the government in power needs minority votes to win (in fractionalized party systems and sometimes in less fractionalized systems) it will prevent the riots

Horowitz -- thinks that ethnic conflict is everywhere Two characteristics determine the nature of conflict -ranked vs. unranked systems
 -locus of conflict - do certain cleavages threaten to take over the central state? (dispersed or centralized conflict)
